FISHING WITH LEAD SINKERS - ARE <u>YOU</u> STILL USING THEM?

THERE'S A GOOD ARTICLE IN THE LATEST ISSUE OF THE DNR PUBLICATION, "MINNESOTA CONSERVATION VOLUNTEER"*

IT BASICALLY STATES THAT SMALL SPLIT SHOT LEAD SINKERS (THAT WE ALL USE FOR PANFISH!) ARE KILLING OUR LOONS.

THE LOONS FIND BROKEN LINES WITH SPLIT SHOT SINKERS AND MINNOWS ATTACHED TO A HOOK. SOMETIMES LOONS SWALLOW FISH THAT HAVE SWALLOWED LEAD SINKERS. THE ARTICLE SAYS, "LEAD POISONING IS AN UNPLEASANT WAY TO DIE" AND THAT, "A 1/16TH OZ. LEAD SPLIT SHOT SINKER CAN KILL A LOON IN A MATTER OF WEEKS.

SO, WHAT IS THE ALTERNATIVE? HOW DOES ONE KEEP THEIR BAIT DOWN IN THE WATER WITHOUT A LEAD SINKER?

UNLEADED SINKERS - TIN! BUT, THEY CAN BE DIFFICULT TO FIND. FEW SPORTING GOODS STORES HAVE THEM - AND THEY COST A LITTLE MORE! BUT MAYBE THEY ARE WORTH IT TO HELP PROTECT THE LOONS.

A SHOP WHERE I FOUND THEM (56 FOR \$2)

WAS IN PARK RAPIDS. TWO OTHER STORES DID NOT STOCK THE 'ENVIRONMENTALLY FRIENDLY' TIN SINKERS. PEOPLE DISAGREE ON THE EFFECTS OF THE LEAD BAIT/SINKERS.

BUT, I AM GOING TO CHECK MY TACKLE BOX AND TEACH MY GRANDKIDS NOT TO USE LEAD.

AND, <u>PLEASE</u> DON'T THROW YOUR OLD LEAD SPLIT SHOT SINKERS IN THE LAKE! HUBBARD COUNTY SOLID WASTE SAYS IT IS O.K. TO PUT THEM IN YOUR TRASH.

ALL 6TH GRADERS IN HUBBARD COUNTY WERE BUSED IN FOR THE ALL DAY ENVIRONMENTAL LEARNING EVENT (LAPORTE SCHOOLS, NEVIS & PARK RAPIDS & AKELEY?). - OVER 300 STUDENTS.

WELL, YES, VEGETATION IS GOOD FOR SOME FISH BUT SOMETIMES THERE GETS TO BE TOO MUCH OF THOSE WEEDS!

THIS ISN'T GOING TO SOLVE ALL OUR PROBLEMS AND GET THESE LAKES INTO THE BELOW 40 CATEGORY - BUT-

"PHOSPHORUS IS TURNING OUR BLUE LAKES GREEN! " SAYS AN ARTICLE IN THE "MN ENVIRONMENTAL NETWORK"

WE ARE PINPOINTING DISHWASHER DETERGENT AS A PROBLEM AREA THAT MAY BE AFFECTING OUR LAKES WEED GROWTH! THE ARTICLE STATES THAT SEVERAL OF THE BEST SELLING DISHWASHER DETERGENTS HAVE A PHOSPHORUS CONTENT ABOUT THE SAME AS 'MIRACLE -GRO' (6 TO 8% - AND THAT ISN'T GOOD FOR OUR LAKES!).

FOR YOUR SUMMER BUGS!

(THIS ADVICE WAS ON THE INTERNET)

OK, mosquitos...prepare to be repelled!!!!!

Use Bounce Fabric Softener Sheets....just wipe on & go...Great for Babies

Bob, a fisherman, takes one vitamin B-1 tablet a day April through October. He said it works. He was right. - Hasn't had a mosquito bite in 33 years. Try it.

If you haven't volunteered for the festival, you should try it. You'll come away very tired, but you will feel so good about the whole experience, you will never forget it! The festival couldn't happen without the support from all the lake associations! Darrin Moe of the SWCD works so hard to get things organized and to find the monies. Especially with all the budget cuts this year! He was out drumming up support from organizations from all over the county. Thanks also to the DNR, Hubbard County Environmental Services., the Mantrap Conservation club for the wonderful lunch for the volunteers, and of course the great presenters!

COLA also shared with the Minnesota Extension Office in getting the word out on the "Shoreland Volunteer Workshop". This is an ongoing training that enables people contribute to their community. We are taught to be an informed resource for our lake, and to volunteer at least 20 hours a year in local projects or programs.

COLA assisted the Minnesota Extension Office and Portage Lake alert lakes on Curly Leaf Pond Weed and other invasive aquatic plants. If you had gone out on a pontoon ride with us, and viewed the extent of the Curly Leaf Pond Weed in Portage Lake, you would be out on your boat the next day checking out the plants on your lake! It is amazing the devastation that can occur so quickly on a lake! Some people can't even get their docks out, or get through with their boats. Portage lakeshore owners are having to spend a tremendous amount of money to chemically eradicate this plant, and it may not be successful! It is better to be vigilant and stop any invasive plant from getting a start on your lake!

These are just one week's worth of projects that COLA is involved in. Please support COLA, and your lake association. Without you, we cannot continue to provide the services that are so important to our lake communities. I hope that you all have a wonderful summer with your families and friends!

ATTENTION! BY KARI TOMPERI

An opportunity for 3 (possibly 4) Lake Associations, exists to partner with Wadena County in an Initiative Foundation Healthy Lakes and Rivers Partnership Program. The program is set up so that lake groups in the program are able to earn grants for their organization. The end result is a workable Lake Management Plan specific to your organization's water body.

The program has been offered successfully through the Central Minnesota Initiative Foundation in their 14 county area and the hope is to extend it as a pilot program in partnership with the Northwest Initiative Foundation. This is an opportunity for both Wadena and Hubbard County. The thought is that as the required eight lake or river organizations attend training together and build a communication network, they can be a resource for each other. There are four "milestones" at which your Lake Association team will earn grant dollars;

When five (of the same) people representing your association attend two one-day training sessions you will automatically earn \$400;

When you host a professionally facilitated "visioning session" with your community you will earn another \$400;

When you submit a Draft Lake Management Plan you will earn \$800;

Once you have begun implementation on one of the primary goals and action steps identified in your plan you are eligible for another \$800

In summation, if you complete each of these milestones you will earn \$2,400 in grants. In addition to these grants, a limited number of implementation grants of up to \$5,000 are available directly from the Initiative Foundation to support actions that are proactive (rather than remedial), or — in cases where restoration is necessary — that treat "causes – not symptoms."

To facilitate the presence of seasonal residents, an aggressive time schedule is being developed with the hope that the first training meeting occur at the end of July or early August with the second to follow yet in August. It is important especially in the "visioning" session that all your lake residents are represented. Applications will be available at SWCD offices in Park Rapids and Wadena and will be considered on a 'first come-first served' basis as they are postmarked at Wadena.
