Hubbard SWCD AIS Presentation: Nate Sitz presented information to the lakes that Have watercraft inspectors. As of June 22, 2014: 4, 591 boats had been inspected, Of which 2,193 were entering. 62 had drain plugs in (last year this time 318); 29 boats had water in them (225 last year); 4 Boats sent away to drain water out; 25 boats had vegetation (last year 203); 221 boats entering from infested waters (538 boats last year); 398 boats entering from out of state (724 last year). Boats entered from 26 different states.

- 4. Treasurer's Report: Lynn Goodrich

### **5. Unfinished Business:**

- **a.** Opportunity for dialogue with COLA members information gathering activity update from the Education Committee. Sharon Natzel reported that they received 587 responses with 37 people participating. The Executive Committee will review and compile the results and report at the July 31, 2014 COLA meeting.
- **b. Water and Sports Garage Sale** will be held at the Hubbard County Fair Ground July 11 at the Environmental building. You may drop items off on Thursday July 10 at the Environmental building between 2- 6 PM.
- c. COLA Current Affairs: A brochure has been developed and is available on the COLA website that you can print and take to your lake association meetings for Talking points about COLA.
- **d. Sandpiper pipeline update:** Sharon Natzel and Jeff Mosner reported that COLA opposes the proposed southern route and has sent letters to the Public Utilities Commission (PUC) on the matter. The Friends of the Headwaters group has submitted two alternative routes to the PUC. The Minnesota Pollution Control Agency (MPCA) has submitted their comments and said there were serious flaws in the Sandpiper southern route. There are 28 water bodies that are crossed and many wetlands and in-accessible areas that if a spill were to happen there they could not be contained quickly. On COLA's website there is a link for the Friends of the Headwaters so you can get current information.

#### **6. New Business:**

- **b. Fall 2014 Indiana University Capstone Project:** Burney Fischer will be leading another Capstone project on Hubbard COLA Lake Monitoring. The "Lake Line" magazine will feature an article on a summary of last years Capstone project. It should be available late summer early fall and will be linked to the COLA webpage.

### 7. Committee Reports:

- ➤ The osprey nest on the power line across from Long Lake has a nesting pair again this year. Great River Energy who owns the lines had removed the nest last year after breeding season. Great River Energy and Itasca Mantrap Electric are considering putting a nesting structure a short distance away from where the osprey are currently nesting.
- ➤ Fostering Citizen Leadership in our Watersheds workshop series: Crow Wing SWCD, MN Pollution Control Agency and University MN Extension will be holding a second series of Leadership workshops for people in the Crow Wing, Leech, Long Prairie, Pine and Redeye watersheds. Workshops are free of charge and will consist of three in person Saturday workshops Sept. 6, Nov. 1 and May 2, 2015 and two winter online webinars.
