- 2. Guest Speaker: Tim James, Watershed Coordinator, Minnesota Pollution Control Agency He shared the importance of the aquatic vascular plants which help protect our lakes, provide homes and habitat for songbirds, animals and water fowl that live in and around the riparian zone. There are 150 varieties of aquatic vascular plants in MN. Using global forest watch info, Tim explained the consequences of development on our lakes where prior to development less than 1% of the runoff enters the lake and with development up to 20-30% of surface runoff makes it to the lake. We can affect the runoff. These aquatic vascular plants help provide a buffer zone. He suggested utilizing the DNR's Restore Your Shore materials as a starting point http://www.dnr.state.mn.us/restoreyourshore/index.html
- **3. Enbridge Line 3 Replacement Pipeline public comment period** ends 9/30 at 4:30 pm. Draft Letter from HCCOLA to PUC to be discussed in closed portion of the Sept meeting.
- **4.** Sleeping Fawn Resort / Podunk Poets Concert provided donation of \$2040 to HCCOLA for AIS education. HCCOLA will discuss being one of the sponsors for next year's concert.
- **5.** Water Testing Update Peter Tuomisto reported that RMB Environmental Laboratories found no zebra mussel veligers in our Hubbard County lakes samples this season. Participating lakes should keep your nets for testing next year. Sept 20-21 is final water quality monitoring of the season. Bring your 2-meter sampler and cooler to Charlies by 11 AM Monday 9/21.

Dan Kittilson spoke about cinder blocks (there are over 100 deployed in the county), docks / boatlifts and plant vegetation checks. Our "lake detectors" are asked to provide progress info to Dan. A few more lakes to engage. He recaps in a final report to the state for the county program.
