- 2. Guest Speakers: Bob Berdahl introduced Kevin Farnum, Lake Koronis, and Joe Shneider, Christmas Lake. Kevin described the infestation of starry stonewort in Lake Koronis and their strategies to fight it. It was discovered in August 2015 and is the only lake in Minnesota with this new AIS so there is a learning curve for their lake association and the DNR. Joe informed about the discovery of 5000 zebra mussel juveniles in August of 2014 in Christmas Lake. The DNR quickly attempted to contain and treat the AIS in the infected area but the zebra mussels were able to escape and the battle was lost on the lake by September 2015. Zebra mussels are now found in almost 10% of all Minnesota lake surfaces and other new species are on the way. Most lakes won't recover if infested. Inspection is key.
