• Staffing:

- Goal: Have 45 inspectors on staff by fishing opener
- Current: 42 inspectors on staff
- Conducted Level 1 training on April 21st
- Follow-up secondary Level 1 training scheduled for May 6th



Inspection Schedule Basics

- **14,600** total inspection hours
 - 7,215 state-funded hours
 - 7,385 supplemental-funded hours
- Inspection season runs from May 13th through October 31st
- 34 accesses covered / 32 lakes (no change from 2022)
- Inspection hours focused heavily on weekends and holidays

- How are we addressing the reduction of total hours?
 - Targeted shifts daily and seasonally



- Aqua Weed Stick pilot project
- Starry Trek

- Aqua Weed Sticks HC COLA partnership
 - Expanding on a pilot initiated by HC COLA
 - Will be placing weed-removal tools at nearly every access in the county
 - Provide a means in which boaters can take a pro-active role in AIS prevention
 - Newspaper article will introduce the tools and increase public awareness
 - Hopefully over time, this will encourage watercraft users to invest in their own AIS tools

Starry Trek

- Hoping to expand on our 2022 success
 - 28 accesses sampled
 - No new AIS found
- Will be focusing on lakes experiencing higher traffic from boats coming from designated SSW infested lakes (>10% incoming watercraft)



- Resorts HC COLA partnership
 - Actively promote the AIS program to local resorts create a partnership
 - Many resorts have experienced ownership changes over time
 - Create and re-establish contacts
 - Focus on Starry Stonewort
 - Hoping to prevent a situation such as the one which occurred on Leech Lake
 - SSW was identified and found to be well-established at a private resort/boat launch

Radio and Newspaper

- Radio ads promoting the decontamination unit
 - Decontaminations were down significantly from 2021 to 2022
 - Decontamination numbers were down statewide....?
- Newspaper articles highlighting seasonally relevant AIS topics
 - Spring Education / Summer Water / Fall Weeds
 - Respond to AIS issues as they arise
