- Social Marketing strategies have been successfully utilized in many US and worldwide campaigns (examples: Smokey the bear-prevent forest fires, New Zealand AIS prevention, wear seat belts, prevent drunk driving, stop texting while driving, "see something say something", plus dozens more).
- HC COLA with your Lake Association is starting a project to continue the fight against AIS using Social Marketing strategies.
- The goal is to get the message to every user of HC waters and to change any existing bad behaviors
 that are a risk to the introduction and spread of AIS. We want users to eliminate bad behaviors, adopt
 new behaviors and to sustain these behaviors in the years to come.
- The project team will work this winter in order to have strategies available for the 2018 summer.
- Watch for communication beginning this spring about sustainable AIS prevention behaviors.

If your lake needs a used clean zmv plankton net for sampling, please let Sharon know. These samples can be tested for spiny waterfleas if your lake association wants to pay the additional fee like last year.
