

#### Burney Fischer provides an update from the Vilas County WI study related to our May-June 2021 Exercise on *"Exploring How Lake Associations Think About Their Lakes and the Shared Responsibility to Sustain Them"*

Remember this past May-June, 2021 when Burney Fischer led us through an exercise "Exploring How Lake Associations Think about Their Lakes and the Shared Responsibility to Sustain Them". As he explained to us the process was modelled after a research project conducted with Lake Associations in Vilas County WI. Burney's May-June, 2021 "Lake Change" worksheets, slides and short presentation are here as a reminder:

Now, a final research paper from the project conducted with Lake Associations in Vilas County WI has just been published:

Burney suggests that some of the statistical analysis in the paper is quite complicated and probably beyond the interest of most of us but the discussion and conclusions are very much of interest. Tables 5 & 6 are the most important things to focus on. The paper's conclusion is that lakes are social-ecological systems and that there are multiple pathways (institutional, social and ecological) to consider to help overcome collective action dilemmas that can lead to various outcomes. And finally, there are no panaceas to achieving lake sustainability – it's hard work.
