



Pete Jacobson, Hubbard County Soil & Water Conservation District (HC SWCD) explains the 5 conservation easement programs in the county for privately owned priority parcels which will benefit lakes & streams plus preserve the land in its natural state. When an easement contract is completed, the landowners are paid a percentage of the unimproved value...and retain ownership. The land stays on the property tax roll.



Our AIS Prevention Preparations for Open Water Season

The HC COLA Education Team has some complimentary posters available for your lake association kiosks, etc. Through a <u>community based social marketing survey</u> with 1,965 angler responses, the MN DNR found anglers prefer to receive AIS information at the boat ramp, bait dealer and fishing pier and fishing access points. Nitrates in Well Water – What You Should Know

Marcel Noyes, Hubbard County Soil & Water Conservation District (HC SWCD) highlights special nitrate test dates / locations for nitrate testing. Natural levels of nitrate in Minnesota groundwater are usually quite low (less than 1 milligram per liter [mg/L]. Sources of nitrate such as fertilizers, animal wastes, or human sewage are concentrated near the ground surface; nitrate may seep down and contaminate the groundwater. Elevated nitrate levels in groundwater are often caused by run-off from barnyards or feedlots, excessive use of fertilizers, or septic systems. Wells most vulnerable to nitrate contamination include shallow wells, dug wells with casings that are not watertight, and wells with damaged, leaking casing or fittings...
