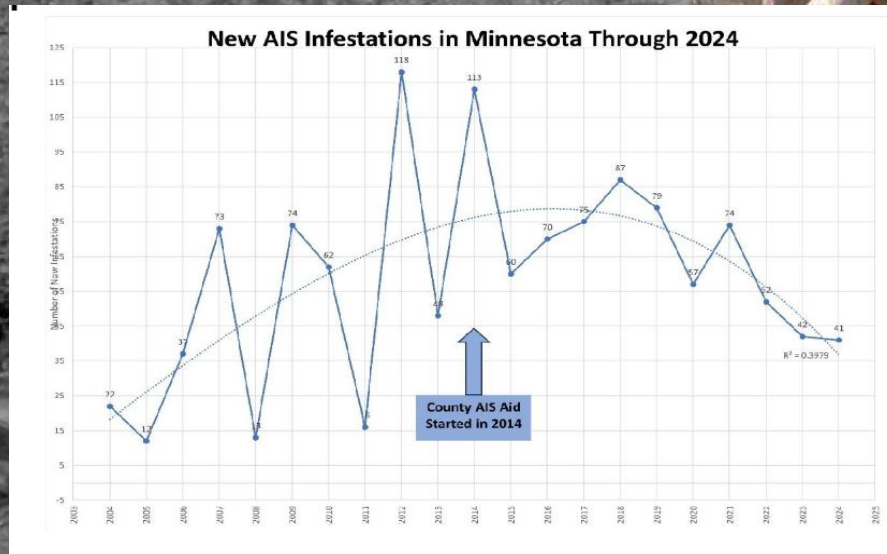
State AIS Updates – State budget

- Governor's Budget Recommendations: *(From revised budget forecast March 21, 2025)*
 - FY 2026-27 (7/1/25 – 6/30/27)
 - **5 million reduction (starting FY2027)**
 - FY 2028-29 (7/1/27 – 6/30/29)
 - **5 million reduction each year**
- **Funding may be significantly reduced starting 7/1/2026.... Stay tuned.**

State AIS Updates – State budget

- What would the impact be? -

- From the Minnesota Aquatic Invasive Species Research Center (MAISRC):
 - Research has shown a marked decline in the rate of AIS spread since Prevention Aid started in 2014.



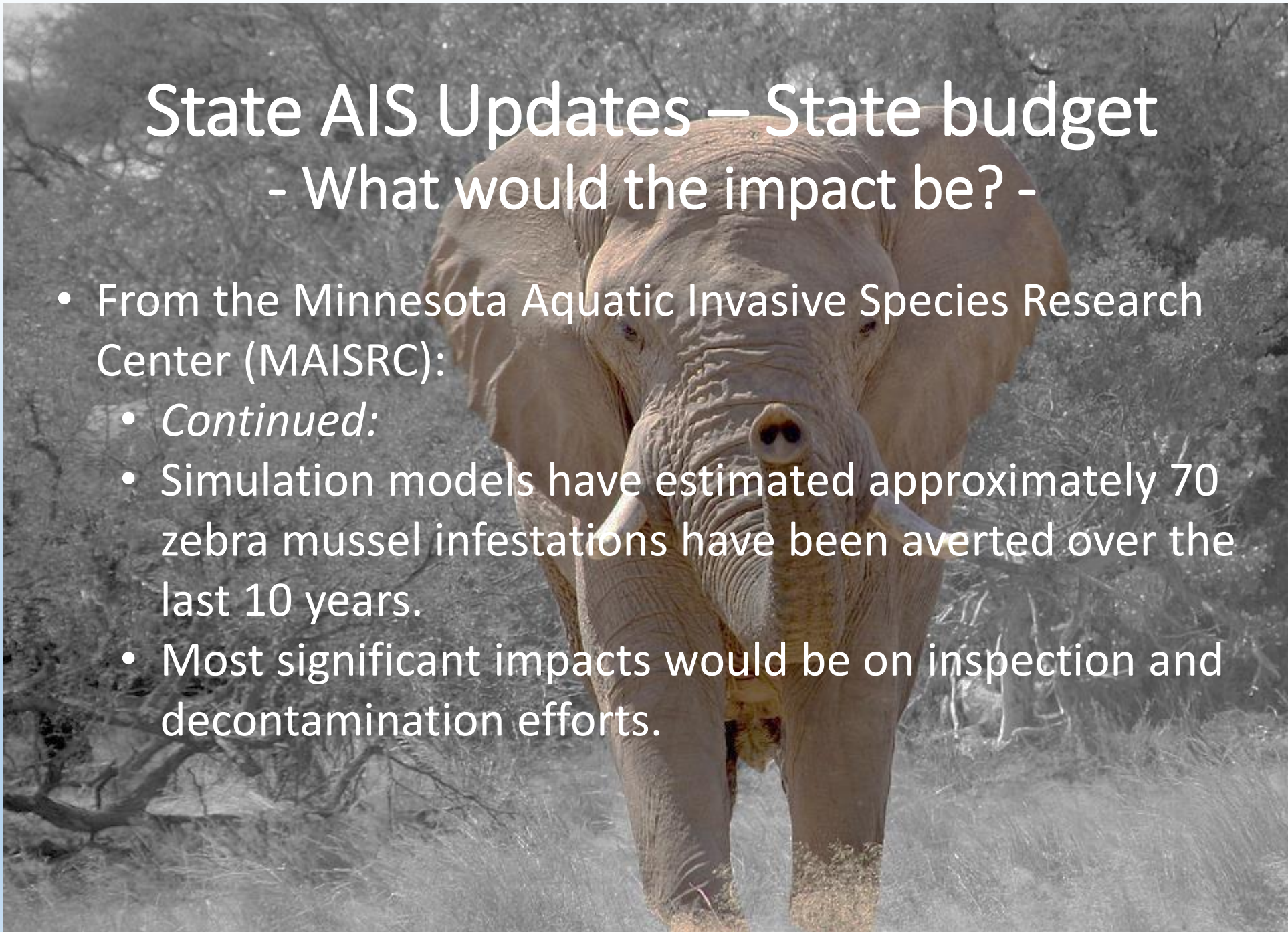
- The X axis is year

State AIS Updates – State budget

- What would the impact be? -

- From the Minnesota Aquatic Invasive Species Research Center (MAISRC):
 - *Continued:*
 - Simulation models have estimated approximately 70 zebra mussel infestations have been averted over the last 10 years.
 - Most significant impacts would be on inspection and decontamination efforts.

State AIS Updates – State budget

- What would the impact be? -

Local impact with 50% State Aid:

- If maintaining current staffing levels, supplemental funding and inspection strategies:
 - We would still have enough hours to cover weekends, holidays and select weekdays.
 - Estimated 13,000 watercraft inspections/year at a rate of 1.60 inspections per hour.
 - *Down from ~ 20,000+ per year at 1.40 insp/yr.*

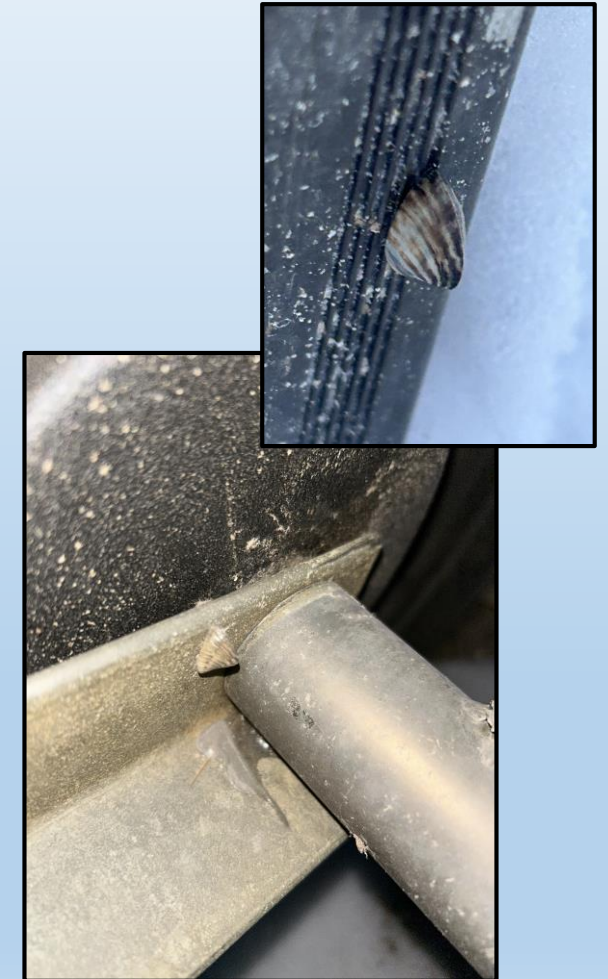


State AIS Updates – State budget - Response -

- Hubbard County Board of Commissioners voted to join as signatories in a letter sent to the Governor's office submitted by Wildlife Forever, requesting full funding for AIS Prevent Aid.
- AIS Operating Team members have continued to reach out to local representatives, receiving correspondence.
- 2025 Emphasis – ***BE YOUR OWN INSPECTOR***

State AIS Updates – Close to home

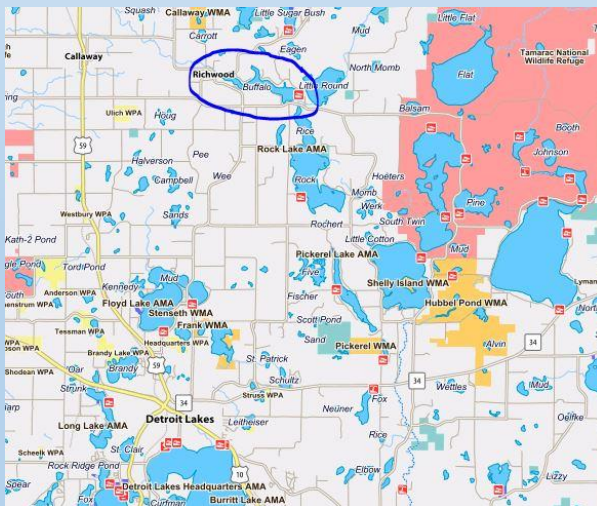
- October 2024: ***Potato Lake – zebra mussels***
 - Adult mussels found in three locations across the lake.
- February 2025: ***Fish Hook Lake – zebra mussels***
 - Adult mussels found at multiple locations along north shore.
- As a precautionary measure...
 - Island, Eagle, Mud, and Upper Twin Lakes.
 - Hay Creek, Potato, and Fish Hook Rivers.
 - ***All have been designated as infested with zebra mussels.***
 - ***No zebra mussels have been discovered at this time.***



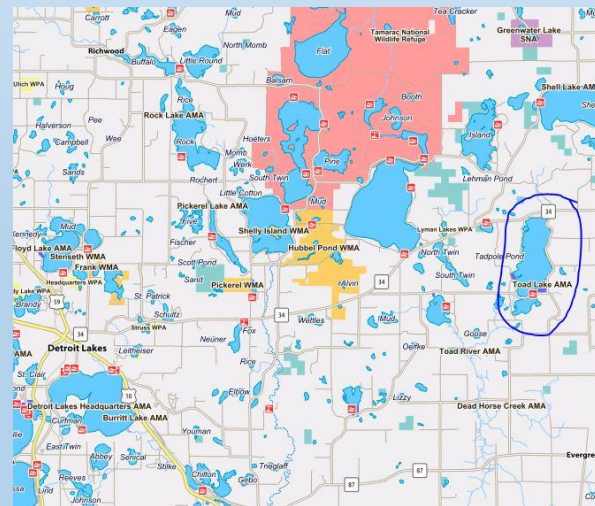

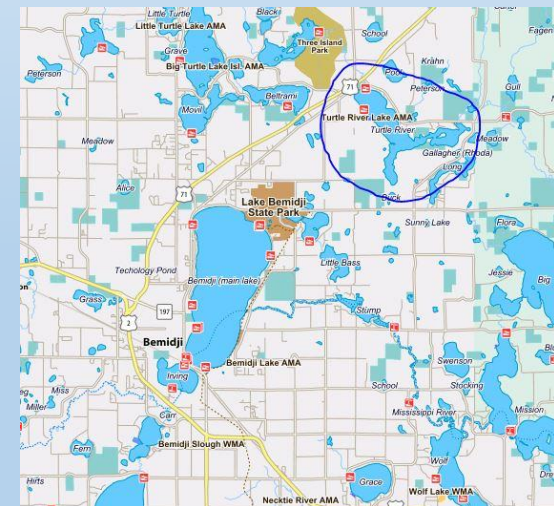
- ***New infestations, 2024***

Watercraft Inspection Program Outlook

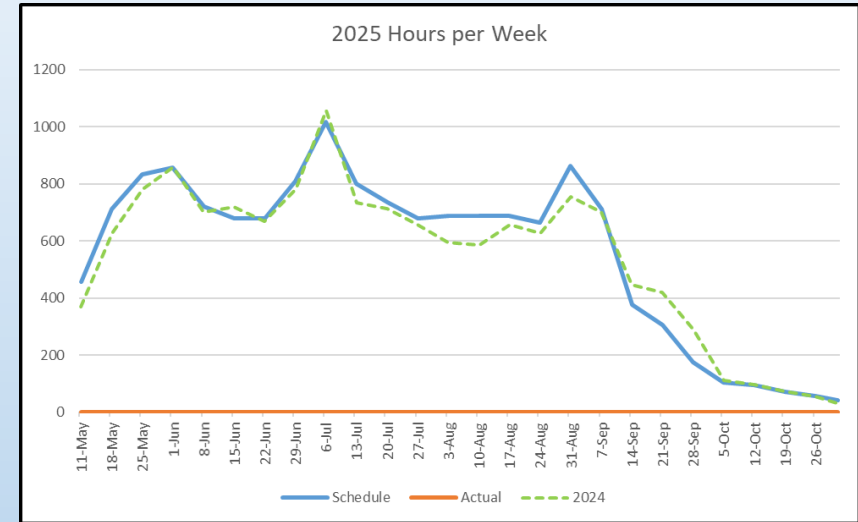
- **Funding:**
 - Lake Associations & Organizations
 - 22 donors
 - \$158,443
 - Townships & Cities
 - 12 donors
 - \$33,100
 - Total:
 - 34 donor organizations
 - \$191,543



Watercraft Inspection Program Outlook

- **Inspection Schedule Basics**

- **14,504** total inspection hours
 - 7,090 state-funded hours
 - 7,414 supplemental-funded hours



- Inspection season runs from May 10th through October 31st (*175 day season*)
- 36 accesses covered / 34 lakes & rivers
- Inspection hours focused heavily on weekends and holidays

Watercraft Inspection Program Outlook

- **Staffing:**

- Have 41 inspectors on staff thus far
- 31 returning inspectors, 10 new inspectors
- Conducting Level 1 & 2 DNR trainings on May 3rd
- In-field trainings on Friday, May 9th

2025 Outreach Objectives

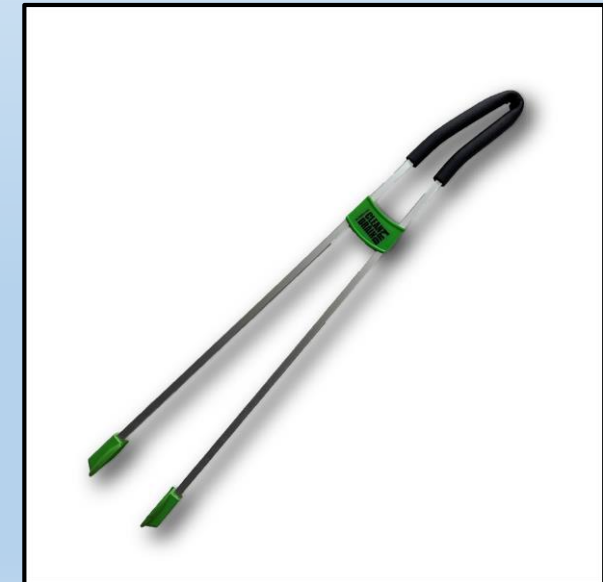
- **Aqua Weed Sticks – HCCOLA partnership**
 - Originally initiated by HC COLA in 2022
 - Will be placing weed-removal tools at nearly every access in the county again in 2025
 - Boaters can take a proactive role in AIS prevention
 - Create good habits!
 - 22 sticks went missing in 2023
 - 15 sticks went missing in 2024 – improvement!
 - Weed sticks will start being placed beginning of May
- Also being placed....



2025 Outreach Objectives

- **More Tools!** – *HCCOLA initiative*

- Expanding the AWS concept
- Boat plug wrenches
- Weed grabbers
- Brushes

2025 Outreach Objectives

- **Starry Trek 2025 – *MAISRC partnership***
 - 2024 Recap:
 - 20 public accesses sampled
 - Chinese MS found in 6th CW, Eagle & Emma Lakes
 - Statewide, 297 accesses sampled – no new starry stonewort discoveries – good news!
 - 2025: Saturday, August 9th – circle your calendars!
 - Specific lakes TBD
 - Will be coordinating with HCCOLA and their “*Rake Toss Tuesdays*” initiative.

2025 AIS Emphasis:

Eurasian Watermilfoil

Keys to ID:

- Feathery looking, with four leavers per whorl
- Leaves have central axis, with 12-20 leaflet pairs
- Can grow up to 10 feet long
- Produces pink and white flowers on spike above surface
- Leaves become limp when removed from water (native milfoils remain rigid)

Eurasian watermilfoil is a submerged, rooted, aquatic perennial plant. These plants generally prefer slow-moving water, growing in depths of 3 to 10 feet but have been known to occur in depths up to 32 feet.

This plant spreads primarily through fragmentation, but may also spread by seed. Once established, Eurasian watermilfoil forms dense stands, impeding boating, fishing and swimming.

This plant is often mistaken for native species such as northern watermilfoil and coontail. Eurasian watermilfoil is known to hybridize with northern milfoil, creating more vigorous and aggressive forms.

If found early, Eurasian watermilfoil can be controlled and managed with herbicide treatments. Management can be difficult and expensive however. Prevention remains the most important and effective management option. Keep boats, trailers, water equipment and water toys cleaned, well-drained, and dry!

Let's work together to stop the spread of AIS!

Currently, 2 of Hubbard County's 185 lakes are listed as infested with Eurasian watermilfoil:

- Bad Axe (2017)
- Big Mantrap (2020)

Only 1% of Hubbard County lakes have Eurasian watermilfoil.

Other lakes in the neighborhood infested with Eurasian watermilfoil (county, year):

- Leech (Cass, 2005)
- Town Line (Cass, 2009)
- Washburn (Cass, 2009)
- Girl (Cass, 2017)
- Lawrence (Cass, 2023)

INSPECTION CHECKLIST	
CLEAN:	
<input type="checkbox"/>	Inspect trailer frames, axles, wheels and lights.
<input type="checkbox"/>	Inspect boat motors, trolling motors, transom and casting decks.
<input type="checkbox"/>	Inspect equipment such as bait buckets, anchors, fishing tackle and water toys for plants and animals.
<input type="checkbox"/>	Inspect boat hull and water intakes for attached plants and animals such as zebra mussels & snails.
<input type="checkbox"/>	Feel the hull below the waterline. New, young zebra mussels leave a sandpaper-like texture.
DRAIN:	
<input type="checkbox"/>	Pull drain plugs from rear of the boat and all internal compartments.
<input type="checkbox"/>	Lower motor to drain excess water from inside the engine.
<input type="checkbox"/>	Drain all bait-water and replenish with fresh tap water.
DRY:	
<input type="checkbox"/>	Allow the watercraft to dry for 5 days prior to your next launch.
<input type="checkbox"/>	Keep compartments open during storage to allow air-flow through internal plumbing.
DISPOSE:	
<input type="checkbox"/>	Throw unwanted bait in the trash.
<input type="checkbox"/>	Place broken fishing line in the trash.

Do **your** part to prevent the spread of **AQUATIC INVASIVE SPECIES**

- **CLEAN:** remove all animals & vegetation from boat and trailer
- **DRAIN:** pull all drain plugs and drain water-related equipment
- **DRY:** sponge out standing water, let dry for at least 5 days
- **DISPOSE:** throw unwanted bait (including minnows) in the trash
