

## Updates of Interest to Aid in Protecting & Preserving Lakes / Wildlife

## **I. Empowering Citizens To Take Action To Protect and Maintain High Quality Fisheries and Water Resources**

The Hubbard SWCD has received a grant from the [Midwest Glacial Lakes Partnership](#) to assist in promoting community driven water quality and fisheries protection across three chains of lakes. We have partnered with the Crow Wing County SWCD and a Bemidji State University graduate student to promote and educate shoreland owners on a variety of shoreline and water quality protection methods. This will consist of a variety of virtual and in person events to discuss and show off a variety of shoreline protection and stormwater management practices to protect area lakes.

These events will be hosted by SWCD staff in collaboration with the graduate student from BSU working on this grant. **Lakes of focus in Hubbard County** include **Belle Taine, Upper and Lower Bottle, Mantrap, Big Sand, Little Sand, and Lake Emma** due to ecological roles and fisheries of these systems. However, we encourage anyone interested no matter where they reside to join the virtual and field events.

The goals of these events are to show and educate attendees on how they can make their shoreland water quality friendly in a variety of methods from small DIY projects to larger scale restorations. Details of agendas and dates of these events will be announced at a later date.

### III. Hubbard Lake Associations' Loon Liaisons Discuss Next Steps with the MN DNR Loon Restoration Project Staff



Both Elizabeth (Liz) Rasmussen and Spencer Rettler are working on populating the initial Loon-Friendly Lake Management Plan drafts where lake associations have identified loon liaisons with help from Rob Rabasco, NR Program Coordinator – MLRP. Beginning this year, Garfield Lake has made the DNR Quality Sunfish program list with the reduced daily limit of five Sunfish. The Garfield Lake Association team explained that this is a great achievement by all the people who helped this happen! This will help the recovery and increase the size of the fish over time.
