

With April's early ice out, docks are starting to be placed in the water and an occasional boat is heard on the water! Our spring showers are helping the green appear in the landscape as trees bud and early bushes flower. It feels good to be cleaning the yard.

This year, I am carefully leaving some leaf litter in the shoreland buffer area and gardens to encourage fireflies which have dwindled over the years. I learned too through **Firefly.org**, that long grasses and low hanging trees are also welcome environments. Reducing the night light in our yard by drawing the blinds and using motion sensing lights will help so the fireflies can signal to each other with



their flashing lights. This helps the fireflies find each other and build generations!

# Invasive Zebra Mussels Found in Aquarium Moss Balls



On March 2nd, a nationwide alert led to the discovery of zebra mussels in moss balls used in aquariums and sold in pet stores in over 25 states, including MN pet stores. The large pet stores stopped selling the moss balls. The educational focus is now the small retailers and aquarium owners. State and federal officials are concerned if live mussels are released into a storm drain or flushed into the sewer, they could eventually be introduced into a nearby waterway. Detailed information on proper disposal and disinfecting tanks, pumps and accessories is being widely publicized. MN DNR community-based social marketing (CBSM) effort is focusing on <u>retail aquarium</u> and aquatic plant trades identified as major pathways for AIS movement.

The Hubbard County Board of Commissioners will hold **<u>public hearings</u>** at the HC Government Center in May for the purpose of amending these County Ordinances:

- #31 Subsurface Sewage Treatment System on May 4, 9:30 AM
- #34 Signage on May 4, 9:30 AM
- #35 Subdivision Ordinance on May 18, 9:30 AM
- #17 Shoreland Management Ordinance on May 26, 6 to 9 PM & if needed May 27

The public is invited to attend in person or virtually to present oral comment. Citizens may send written comments on the proposed amendments. Drafts can be viewed online or in the County Administrator's Office during regular business hours. HC COLA will review the amendments & provide written comments to the commissioners. **MORE**
